Asset Specialists, Inc. is pleased to Announce the Sale of  $\pm 220,000$  sf of Industrial Warehouse Buildings in Port St. Lucie, Fla. known as the "CES Portfolio".

PALM BEACH GARDENS, FL – December 18, 2020 – Asset Specialists, Inc. (hereinafter referred to as "ASI") is pleased to announce the sale of one (1) vacant land parcel and five (5) industrial warehouse properties totaling ±220,000 sf in the Enterprise Industrial Park of Port St. Lucie, Fla. ASI, with its capital partners, acquired the CES Portfolio in July of 2018 for \$10,500,000.00 with a single tenant in place for all buildings at below market rents while their new facility was being constructed. Upon the in-place Tenant vacating the buildings; Asset Specialists, Inc. began marketing and selling the buildings individually with the first sale occurring in May of 2019 and the last sale occurring in December of 2020. The breakdown of the portfolio sellout is as follows:

- 1) 603 NW Commodity Cove is a 5,898 sf building situated on 0.56 acre which was sold to an owner-user in May of 2019 for \$880,000.00.
- 2) 635 NW Enterprise Drive is a 13,250 sf building situated on 1.49 acres which sold to an owner-user in July of 2019 for \$1,550,000.00.
- 3) 400 NW Enterprise Drive is a 84,000 sf building situated on 5.08 acres which sold to an investor in December of 2019, collectively with one other building in the portfolio and a vacant land parcel for \$10,300,000.00.
- 4) 660 NW Peacock Boulevard is a 55,000 sf building situated on 3.13 acres which sold to an investor in December of 2019, collectively with the above referenced 400 NW Enterprise Drive property and the above referenced vacant land parcel.
- 5) 460 NW Enterprise Drive is a 62,000 sf building situated on 5 acres which sold to an investor in December of 2020 for \$5,500,000.00.

## Total Portfolio Sellout: \$18,230,000.00
